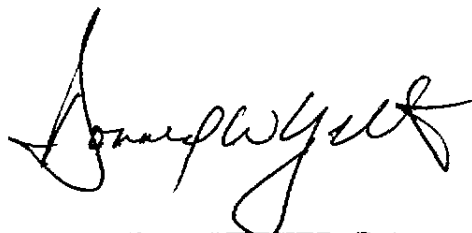

**ARTICLES OF ORGANIZATION**

**OF**

**GREG HANSON WELDING AND FABRICATION, L.L.C.**

**ARTICLE I - NAME**

**THE NAME OF THIS** Limited Liability Company shall be **GREG HANSON WELDING AND FABRICATION, L.L.C.**

**ARTICLE II - ADDRESS**

**THE MAILING ADDRESS** and street address of the principal office of the Limited Liability Company shall be 3857 Martin Street, Orlando, Florida 32806.

**ARTICLE III - DURATION**

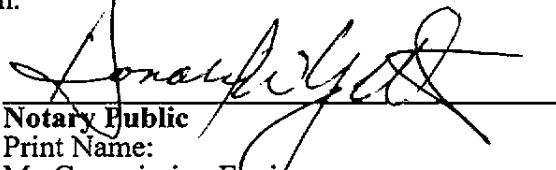

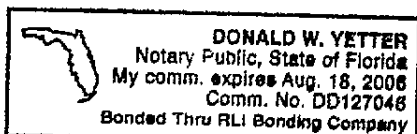
