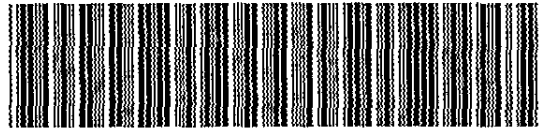

Management of Business

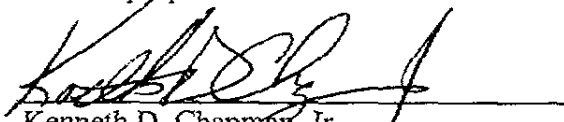
Management of the Company shall be vested in its manager(s). Accordingly, the Company shall be a manager-managed company.

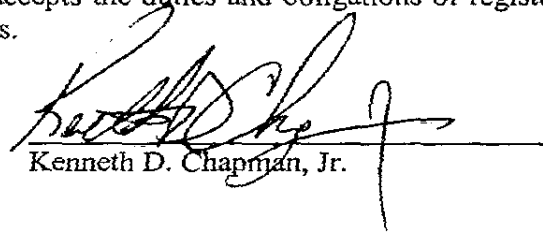
