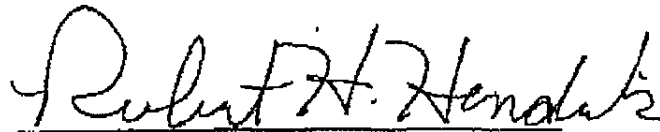
ARTICLE IV
