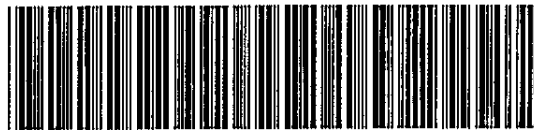

**ARTICLE I – Name:**

The name of the limited liability company is Emerald Coast Airways, LLC.

**ARTICLE II – Address:**

The mailing and street address of the company is 5205 Nimitz Road, Milton, Florida 32583.

**ARTICLE III – Purpose:**

The company has been organized for pulmonary function testing and any other lawful business.

**ARTICLE IV – Initial Members:**
