The undersigned, for the purpose of forming a limited liability company under the Extida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be Nicholls Investment Properties, LLC ("Company").
