The name of the Limited Liability Company is **BUSINESS POWER CONSULTANTS, LLC**.

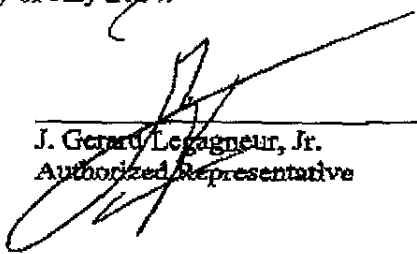

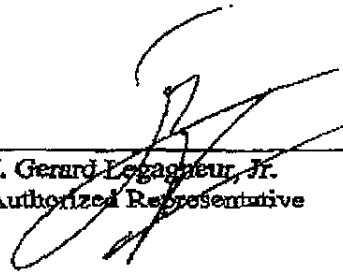

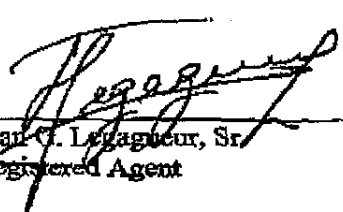
