**ARTICLES OF ORGANIZATION
OF
PARKER TECHNOLOGIES GROUP, L.L.C.**

The undersigned hereby certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit and hereby adopt the following Articles of Organization for such limited liability company:

**ARTICLE I
NAME AND PRINCIPAL OFFICE**

The name of this limited liability company is **PARKER TECHNOLOGIES GROUP, L.L.C.**, and its principal office and mailing address is located at P.O. Box 120922, Clermont, Florida 34712.

**ARTICLE II
DURATION**

The existence of this limited liability company shall be perpetual, commencing upon the filing of the Articles of Organization by the Florida Department of State.

**ARTICLE III
PURPOSE**

The purpose of this limited liability company is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV
DISSOLUTION**

**ARTICLE V
MANAGEMENT**

**ARTICLE VI
INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office of this limited liability company shall be located at 1795 E. Highway 50, Suite A, Clermont, Florida 34711, and the initial registered agent of the limited liability company at that address shall be RICHARD T. PARKER, JR.
