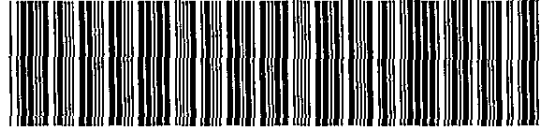

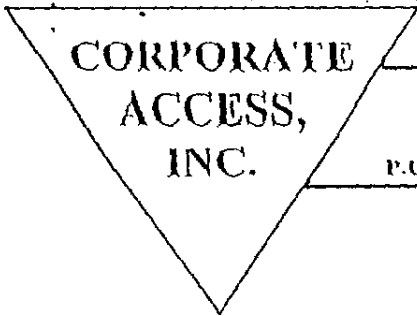

#### ARTICLE VII - AMENDMENT




