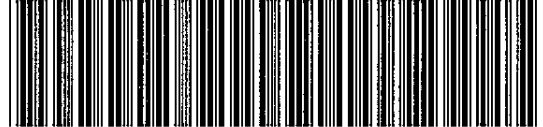

**ARTICLES OF ORGANIZATION
FOR JACKSON LAKES COMPANY, LLC,
A FLORIDA LIMITED LIABILITY COMPANY**

ARTICLE I—NAME

The name of the Limited Liability Company shall be **JACKSON LAKES COMPANY, LLC** ("The Company").

ARTICLE II—ADDRESS.

The mailing and street address of the principal office of **JACKSON LAKES COMPANY, LLC**, shall be:

1016 Shalimar Drive
Tallahassee, Florida 32312

ARTICLE III—MEMBERSHIP; VOTING.

The initial member shall be Donald L. Bell, who shall have the right to create by Resolution of the limited liability company such additional memberships as he considers appropriate, with such rights as he considers appropriate, and to be issued upon such terms as he considers appropriate. The number of memberships can exceed the number of members and, subject to such terms and requirements as may be established by the initial member, each member can acquire and own as many memberships as that member deems desirable. There may be more than one class of membership, including "management memberships" which may be created with super voting rights. A quorum shall consist of members with the authority to vote not less than 51% of the votes of all memberships issued, including any management memberships. A quorum shall be required to convene a meeting of the members or for any vote of the memberships to be taken. A simple majority of the votes cast, including any management membership votes, shall be the act of the Company. Proxy voting shall be permitted, provided that the person voting must have a written proxy signed by the owner of the memberships to be voted.

ARTICLE V—REGISTERED AGENT, REGISTERED OFFICE, & REGISTERED AGENT'S SIGNATURE
