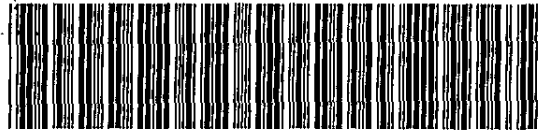

- a. To offer home health care to individuals through corporations, general and limited partnerships, sole proprietors and individuals.


