

The Articles of Organization of Southside Materials Recycling Facility, LLC, a Florida limited liability company (the "Company") are hereby amended and restated in their entirety, in accordance with Section 608.411 of the Florida Limited Liability Company Act, as set forth below. These Amended and Restated Articles supersede and substitute the Articles of Organization of the Company previously filed with the State of Florida on July 19, 2004, as amended.

Registered Office and Registered Agent


