**ARTICLES OF ORGANIZATION
OF
TRIA ARHEDIA, L.L.C.
(a Limited Liability Company)**

We, the undersigned, natural persons of the age of eighteen (18) years or more, acting as the organizers of Tria Arhedia, L.L.C. (The "Company"), under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopt the following Articles of Organization:

ARTICLE 1 - NAME AND ADDRESS

The name and address of the Company is:

ARTICLE 2 - COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the Company will commence on the date of filing of these articles, and the existence of the Company will be perpetual.

ARTICLE 3 - PURPOSE

The Company may transact any or all lawful business for which a limited liability company may be organized under the Florida Limited Liability Act.

ARTICLE 4 - INITIAL REGISTERED AGENT AND OFFICE

The street address of the initial registered office of the Company is 10816 U.S. Highway 19N, Suite 105, Port Richey, Pasco County, Florida 34668, and the name of the Company's initial resident agent at that address is GEORGE C. PSETAS.

ARTICLE 5 - INITIAL CAPITAL CONTRIBUTION

The total amount of cash or property to be initially contributed to the Company by its members shall be as follows:

ARTICLE 6 - ADDITIONAL CAPITAL CONTRIBUTIONS

The members shall make additional capital contributions, from time to time, as required by the Company's regulations.

ARTICLE 7 - ADMISSION OF SUBSTITUTE OR ADDITIONAL MEMBERS

Additional or substitute members may be admitted only upon the unanimous written approval of the members of the Company in a manner set forth in its regulations.

ARTICLE 8 - MANAGEMENT OF COMPANY

The business of the Company shall be managed by the Manager who shall be elected annually by the members of the Company in a manner set forth in the regulations. The Manager shall have the power and authority to act on behalf of the Company as provided in the Florida Limited Liability Act, including, specifically, without limitation, Section 608.404, Section 608.40(1), and Section 608.425, and shall also hold the offices and have the responsibilities accorded by the members which are more particularly described in its regulations and any other Agreement that may be entered into between the members and the Manager. The name and address of the initial Manager is as follows:

The Manager shall serve in that capacity until the first annual meeting of members or until a successor is elected and qualified.

ARTICLE 9 - REGULATIONS

The power to adopt, alter, amend or repeal the regulations of the Company is vested exclusively in the members of the Company.

ARTICLE 11 - AMENDMENT OF ARTICLES OF ORGANIZATION

Any amendment to the Articles of Organization shall be approved by all the members, shall be as preached by the Secretary of State of Florida and shall be sworn and subscribed to by all the members of the Company. In the event that a new member is added by such an amendment, it also shall be signed by the additional member.

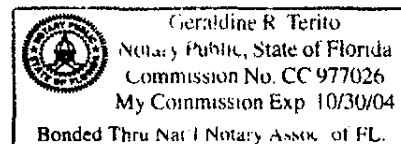
