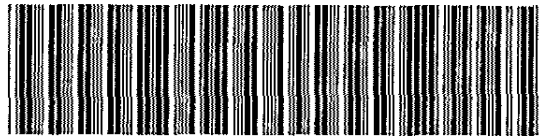

ARTICLE I

The name of the limited liability company shall be Tropical Storage-Miramar, LLC

ARTICLE II

The period of the limited liability company's duration shall be ninety (90) years from the date of filing these Articles of Organization with the Department of State.

ARTICLE III

The purpose for which this limited liability company is organized is to engage in any activity or business permitted under the laws of the United States of Florida.

ARTICLE IV

The address of the principal office of this limited liability company in the state of Florida shall be located at 51 Cayuga Road, in the City of Sea Ranch Lakes, County of Broward, State of Florida, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Chapter 608, F.S.
