The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be JADE NGOC DUOC, LLC.

**ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the company is 10521 Sailaway Lane, Orlando, Florida 32825.

**ARTICLE III - DURATION**

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. The company's existence shall be perpetual, unless the company is dissolved earlier as provided by law or in these Articles of Organization or in the regulations.

**ARTICLE IV - REGISTERED OFFICE AND AGENT**

## **ARTICLE V - CAPITAL CONTRIBUTIONS**

The member or members of the company shall contribute to the capital of the company either cash or property as they may from time to time in their discretion determine.

## **ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS**

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members if more than one member.

The regulations may contain provisions for the regulation and management of the affairs of the company not inconsistent with law or these Articles of Organization.

## **ARTICLE IX - INITIAL MEMBERS**

The company shall have one member initially. The number of members can be increased or diminished from time to time by the Regulations, but shall never be less than one member. The names and addresses of the initial member of the company is:


