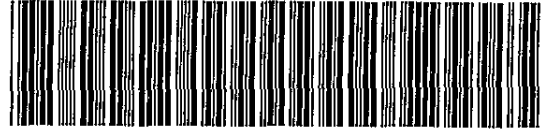

**ARTICLES OF ORGANIZATION
1621 SOUTH 21ST AVENUE,, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act., F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization

ARTICLE I - NAME

The name of the Limited Liability company shall be 1621 SOUTH 21ST AVENUE, L.L.C.

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company shall be 1621 South 21st Avenue, Hollywood, Fl 33320

ARTICLE III - DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless it is earlier dissolved as provided in these articles of organization and by law.

ARTICLE IV - REGISTERED OFFICE AND AGENT

ARTICLE V - ADMISSION OF NEW MEMBERS
