Articles of Organization of

ANGEL PROPERTIES, L.L.C.

a Florida Limited Liability Company

The undersigned Members hereby file these Articles of Organization in order to form a limited liability company under the laws of the State of Florida.

ARTICLE I.

Name

The name of this Limited Liability Company shall be ANGEL PROPERTIES, L.L.C.

ARTICLE II.

Address

The principal place of business, and the mailing address, of this Limited Liability Company shall be 1722 Ferndale Place, Tallahassee, Florida 32301.

ARTICLE III.

Company Purposes & Powers

This Limited Liability Company is organized for the purpose of engaging in any or all activity or business permitted under the laws of the United States and the State of Florida. This Limited Liability Company shall have and exercise all the powers accorded limited liability companies under the laws of the State of Florida.

ARTICLE IV.

Duration

This Limited Liability Company shall have perpetual existence unless dissolved according to law.

ARTICLE V.

Members

This Limited Liability Company shall be managed by a manager or managers who shall be elected annually by the Voting Members in the manner prescribed by and provided in the operating agreement of this



