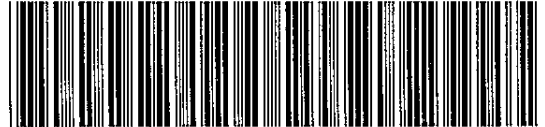

for



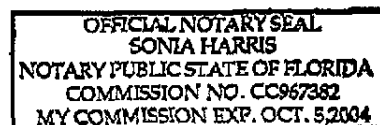


