ARTICLES OF ORGANIZATION
OF
MARLIN GATE, L.L.C.

The undersigned person, acting as the organizer of MARLIN GATE, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is:
