AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF ADVANTIS HOSPITALITY, LLC

Pursuant to Section 608.411, Florida Statutes, the Articles of Organization of Advantis.

Hospitality, LLC, (the "Company") a Florida limited liability company formed on July 23, 2004, and assigned document number L04000054778, are hereby amended and restated as follows:

- 1. Name. The name of the Company is Advantis Hospitality, LLC.
