

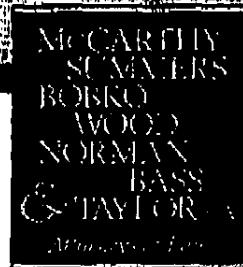


**ARTICLES OF DISSOLUTION FOR FLORIDA LIMITED
