**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be CRUISE INFORMATION CENTER LLC ("company").

ARTICLE II – ADDRESS

ARTICLE III – DURATION

The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.
