ARTICLES OF AMENDMENT
TO THE ARTICLES OF ORGANIZATION
OF
HARBOR VERO MANAGEMENT, LLC

Pursuant to Section 608.411 of the Florida Statutes, **HARBOR VERO MANAGEMENT, LLC**, a Florida limited liability company, hereby adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is **HARBOR VERO MANAGEMENT, LLC**.
