The undersigned hereby certifies that it has formed a limited liability company under the State of Florida.

#### ARTICLE I

#### Name

- (ii) Direct or indirect obligations of the United States or any other government, state, territory, governmental district or municipality, or of any instrumentality thereof.

- (d) Make contracts or guarantees or incur liabilities; borrow money at such rates of interest as the limited liability company may determine; issue its notes, bonds, or other obligations or secure any of its obligations by mortgage or pledge of all or any part of its property, assets, franchises or income.
- Lend money for any lawful purpose, invest or reinvest its funds, or take and hold (e) real or personal property as security for the payment of funds so loaned or invested.
- Conduct its business, carry on its operations and have offices, and exercise the **(f)** powers granted by Florida law, within or outside the State of Florida.
- Elect or appoint managers and agents, define their duties, and fix their (g) compensation.
- (h) Make and alter an operating agreement not inconsistent with these Articles of Organization or the laws of the State of Florida.
- Make donations to the public welfare or for charitable, scientific or educational (i) purposes.
- Indemnify a Member or any other person to the same extent as a corporation may (i) indemnify any of the directors, officers, employees, or agents of the corporation against expenses actually and reasonably incurred by him or it in connection with the defense of an action, suit proceeding, whether civil or criminal, in which he or it is made a party.
  - Cease its activities and surrender this Certificate of Organization, (k)
- **(I)** Have and exercise all powers necessary or convenient to effect any or all of the purposes for which the limited liability company is organized.

- Transact any lawful business which the Members or the managers find to be in aid (m) of governmental policy.
- Pay pensions and establish pension plans, profit-sharing plans and other incentive (n) plans for any or all of its managers and employees.
- (o) Be a promoter, incorporator, general partner, limited partner, Member, associate, or manager of any corporation, partnership, limited partnership, limited liability company, joint venture, trust, or other enterprise.
  - Have and exercise all other powers necessary or convenient to effect its purposes. (p)

#### ARTICLE VI

#### Registered Office and Registered Agent
