ARTICLES OF ORGANIZATION OF PELICAN, LLC

ALISA SERRORANDOS The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, at Chapter 608, Florida statutes, hereby makes, acknowledges, and files, the following Articles of Organization.

ARTICLE I -- NAME
