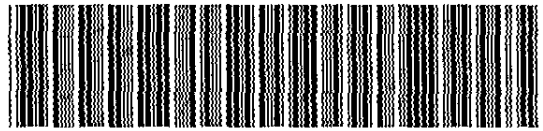

The principal place of business and mailing address of the Company is 4501 Beverly Avenue, Jacksonville, Florida 32210.

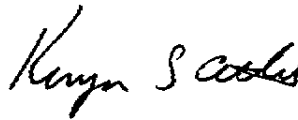
ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

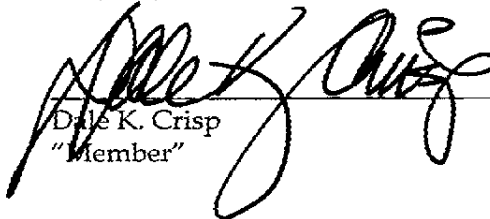
ARTICLE IV - MANAGERS

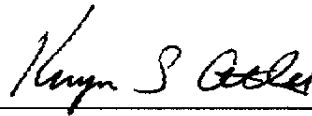
