The Members may permit the admission of Additional Members, upon the unanimous consent of all Members of the Company.


**ARTICLE VII - CONTINUATION OF BUSINESS**

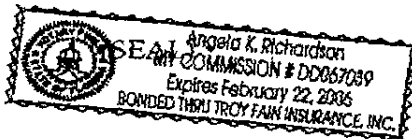

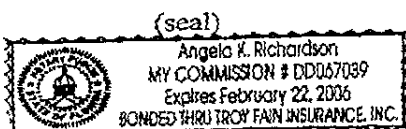


