## ARTICLES OF ORGANIZATION OF HIGHER LEARNING INTERNATIONAL, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be Higher Learning International, L.L.C. (the "Company").

#### ARTICLE II - ADDRESS

The mailing address and street address of the initial principal office of the Company shall be 4949 Bayshore Boulevard, Tampa, Florida 33611.

business and/or affairs of the Company, unless all members of the Company approve of the proposed transfer by unanimous prior written consent. FILED

The Company shall be managed by the member(s) in accordance with regulations adopted by the members for the management of the business and affairs of the Company. The regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
