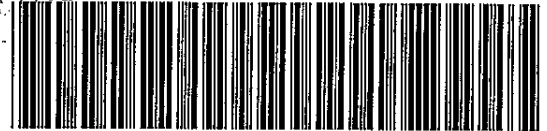


1. **Name.** The name of this company shall be Cordoves L.L.C.


