

ARTICLE VII AMENDMENT OF ARTICLES OF ORGANIZATION

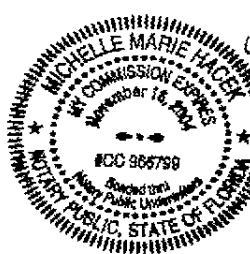
