The name of the limited liability company shall be SILVER DEVELOPMENT COMPANY, LLC (the "Company").

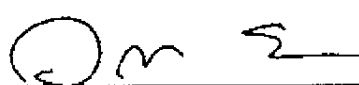
ARTICLE II - ADDRESS

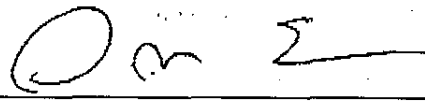
