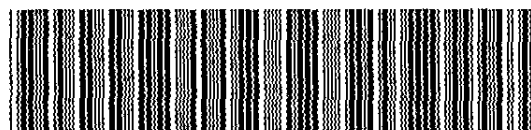

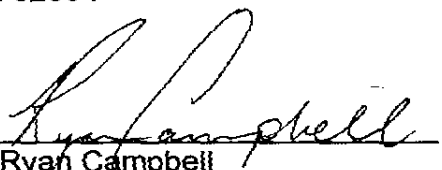
7. **Amendment of Articles.** These articles may be amended by member.
