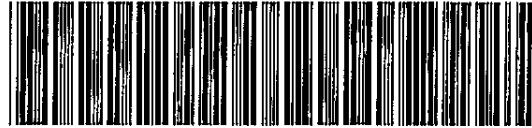

ARTICLE I – Name:

The name of the Professional Limited Liability Company (hereafter “Company”) is:

ARTICLE II – Duration:

The duration of the Company shall be from its date of creation to and until January 1, 2025, unless sooner terminated or extended by agreement of the Members.

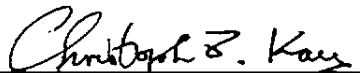
ARTICLE III – Address:

ARTICLE VIII – Additional Members:

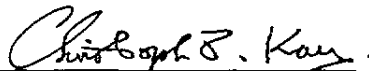
