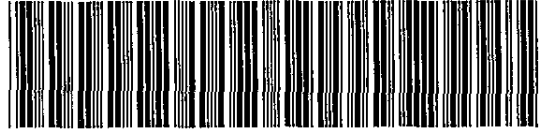

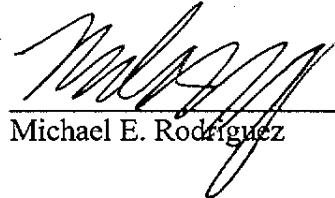

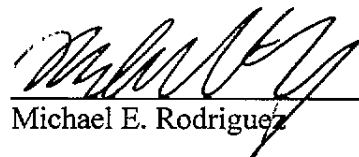
ARTICLE IV – Effective Date
