ARTICLES OF ORGANIZATION

OF

A Florida Limited Liability Company

THE THE PART OF THE STATE OF TH THE UNDERSIGNED, for the purpose of forming a limited liability company under Florida Limited Liability Company Act, adopts the following Article of Organization.

ARTICLE ONE Name and Address


