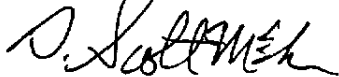

ARTICLE II

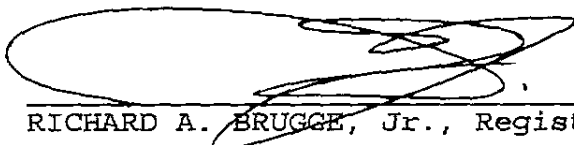

ARTICLE IV

The name and address of the Managing Member of CASWELL LLC is RICHARD A. BRUGGE JR., MGRM, 949 Bruce Ave., Clearwater, Florida, 33767. Future Managers of this Company shall be selected in the manner prescribed by the Operating Agreement of this Company and its authority is derived through such Agreement.

ARTICLE V

The names and addresses of the members and their ownership interest in this Company are:

- (A) RICHARD A. BRUGGE Jr. and JENNIFER E. BOND, joint tenants with rights of survivorship, 949 Bruce Avenue, Clearwater Beach, Florida, 33767; one-third ($\frac{1}{3}$ rd);
- (B) RICHARD A. BRUGGE, Sr., 2628 Sunlight Dr., Arlington, Texas, 76006; one-third ($\frac{1}{3}$ rd);
- (C) VICTORIA P. GLENNON, 342 Larboard Way, Clearwater, Florida, 33767; one-third ($\frac{1}{3}$ rd);

Article VI

A Member's vote shall be per capita. If a membership interest is owned by two or more persons as tenants in common or tenants by the entirety, one vote is allocated equally between all persons holding a membership interest in such manner.

Article VII

The death or adjudication of incapacity of an Owner or assignment of a Member's interest will not dissolve this Company. An assignment of a Member's interest may not be made unless a majority of the non-assigning members approve of such assignment. An assignee of a membership interest may only become a Member upon written approval of all the Members. The adjudication of incapacity

or change of ownership because of death of an owner shall not be considered as an assignment.

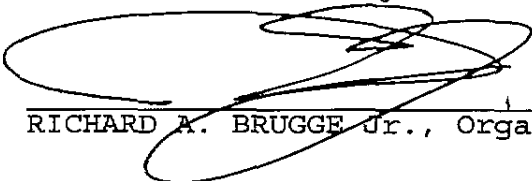
Article VIII

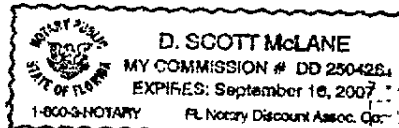
