

### ARTICLES OF ORGANIZATION OF

### **LUNA ASIAN ENTERPRISES LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

### **ARTICLE 1 - NAME**

The name of the limited liability company shall be LUNA ASIAN ENTERPRISES LLC, ("Company").

### **ARTICLE 3 - EFFECTIVE DATE**


These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.
