

## ARTICLES OF ORGANIZATION

**OF**

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be **DORAL DEVELOPMENT GROUP LLC**, ("Company").

#### **ARTICLE 2 - ADDRESS**
