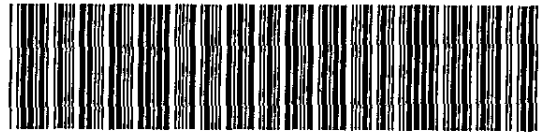



Management of this limited liability company is reserved to its members, each member will have a one-half (1/2) interest in the limited liability company and the names and addresses of the members are as follows:


