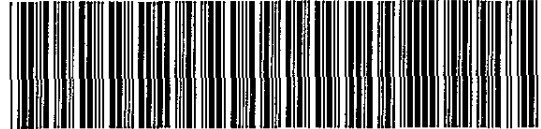

# ARTICLES OF ORGANIZATION OF EKG, LLC

## ARTICLE I – Name:

The name of the Limited Liability Company is: EKG, LLC (the “Company”).
