ARTICLES OF ORGANIZATION
OF
TG UNITED LABS, LLC

The undersigned hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

TG United Labs, LLC

ARTICLE II

Principal Office and Mailing Address

The address of the principal office and the mailing address of the Company shall be:

24295 Hidden Meadows Road
Brooksville, Florida 34604

ARTICLE III

Registered Office and Registered Agent

The initial registered office of the Company shall be located at 24295 Hidden Meadows Road, Brooksville, Florida, 34601, and the initial registered agent of the Company at such office shall be David Ambrose, Jr. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

ARTICLE IV

Operating Agreement

The power to adopt the Operating Agreement of the Company, to alter, amend or repeal the Operating Agreement of the Company, or to adopt a new Operating Agreement, shall be



The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
