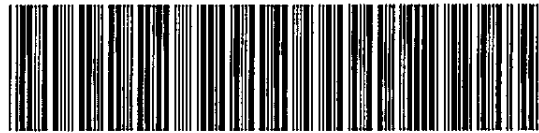


ARTICLE III
