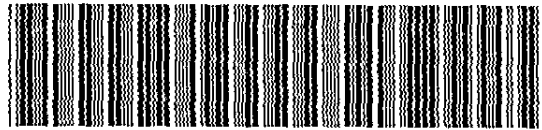

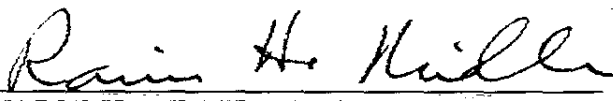
ARTICLE VI

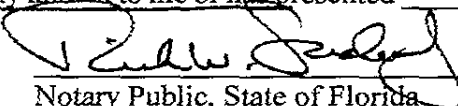

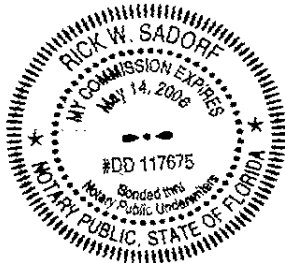
