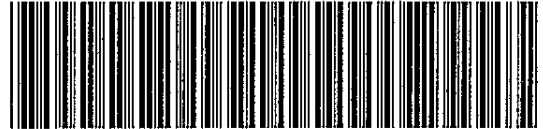

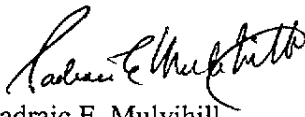

The undersigned hereby certifies that the following Articles of Organization for a Florida Limited Liability Company were duly executed and are being filed in accordance with the provisions of Section 608.407 of the Florida Statutes (2003) as follows:

ARTICLE I

The name of the limited liability company shall be AMASCO Development Group, LLC (the "Company"). The business of the Company shall be conducted under that name or such trade or other fictitious names as the Members may determine.

ARTICLE II

The Company shall commence on the date that the Articles of Organization are filed with the Florida Secretary of State.

ARTICLE III

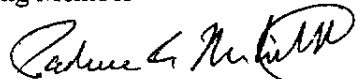

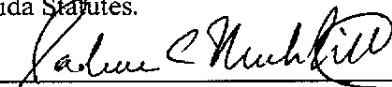
