

ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF RODEIRO DEVELOPMENT, LLC

The undersigned certify that we have as of the date indicated below, amended the Articles of Organization as provided herein, and in connection therewith set forth the following information in accordance with Section §608.411, Florida Statutes:

- 1. The name of the limited liability company is RODEIRO DEVELOPMENT, LLC.
- 2. The date of filing of the Articles of Organization is August 3, 2004.
- 3. The amendment to the Articles of Organization is as follows:

Article III is amended to read as follows:

ARTICLE III

EXERCISE OF POWERS

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed by one manager, who shall be selected by a majority vote of the members of the limited liability company.

ARTICLE VII.

PROFITS AND LOSSES

- (a) Profit Sharing. The members shall be entitled to the net profits arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business of the limited liability company. Each member shall be entitled to an equal distributive share of the profits. The distributive share of the profits shall be determined and paid to the members annually.
