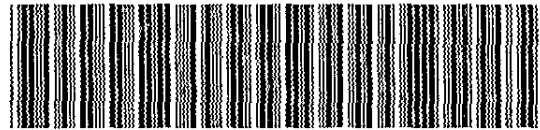



ARTICLES OF ORGANIZATION OF
PAVEMENT GRAPHICS, LLC
A FLORIDA LIMITED LIABILITY COMPANY

1. Name. The name of the Limited Liability Company is Pavement Graphics, LLC, a Florida limited liability company (the "Company").
2. Duration. The Company shall exist from the date of filing of these Articles of Organization with the Department of State until the earlier of fifty (50) years from the date of filing or the occurrence of any of the events specified in the Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.
3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
4. Place of Business. The address of the Company's place of business in the State of Florida is 4125 Chisholm Drive, Sarasota FL 34235. The Company's mailing address is Post Office Box 51463, Sarasota FL 34232.
5. Registered Agent and Office. The name of the initial registered agent of the Company is Peter D. Adams. The street address of the initial registered agent of the Company is 4125 Chisholm Drive, Sarasota FL 34235.
6. Contributions to the Company. The total amount of cash initially contributed to the company by the members is \$100.00. No additional contributions have been agreed upon.
7. Additional Members. Additional members of the company may be admitted, but only upon the unanimous consent of all members of the Company at the time admission is sought.
8. Termination of Membership. Upon death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless the remaining members, by unanimous written agreement, consent to continue the business of the Company.
9. Management of the Company. The management of the Company is to be with a manager. The Company shall be managed in accordance with the regulations and operating agreement adopted by all of the initial members. The name and address of the initial manager is:


11. Regulations. The members shall have the power to adopt, alter, amend, or repeal regulations of the Company containing provisions for the regulation and management of the affairs of the Company.
12. Transfer of Interest. No member shall have the right to transfer any interest in the Company without the unanimous written agreement of all members unless such member shall have complied with the Right of First Refusal provisions of the regulations adopted by the members. If the Company or the non-transferring members who do not elect to purchase the interest, the transferee of the interest of the transferring member shall have the right to become a member and to participate in the management of the business and the affairs of the Company. The income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.
13. Certificated Interests. The members' interests in the Company may be evidenced by certificates.
14. Contracting Debts. The consent of all members shall be required to borrow any money or encumber the Company's property.




