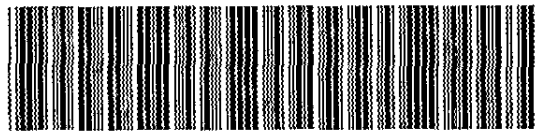

NAME**
