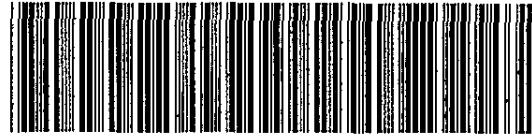

The undersigned subscriber to these Articles of Organization, being a natural person competent to contract, hereby executes this document for the purpose of becoming a limited liability company under the laws of the State of Florida.

ARTICLE I: NAME

The name of this limited liability company shall be:

ARTICLE II: ADDRESS

The principal place of business of this limited liability company 68 Willie Jenkins, Crawfordville, Florida 32327, but it shall have the power to transact business in any other place or places both within and without the State of Florida and throughout the world. 


