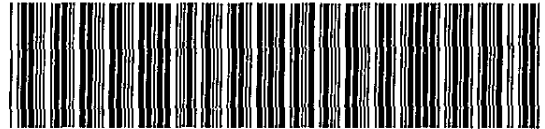

The mailing address and street address of the principal office of the Company is 19101 Mystic Pointe Drive, Suite 1707, Aventura, Florida 33180.


ARTICLE III - Registered Agent and Office
