ARTICLES OF ORGANIZATION OF **AFFINITY STABLES 2004, L.L.C.**

THE PARTY OF THE P The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization:

ARTICLE I: NAME

The name of the Limited Liability Company shall be AFFINITY STABLES 2004, L.L.C. (hereinafter referred to as the "Company").

ARTICLE VI: ADMISSION OF NEW MEMBERS

Except as otherwise provided in the Company's Regulations, additional Members shall be admitted into the Company only with the unanimous written consent of the

Managing Members of the Company, and on such terms and conditions as shall be determined by the Managing Members.

ARTICLE VII: TRANSFERABILITY OF INTEREST

A Member may transfer his/her/its interest in the Company as set forth in the Regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a Member of the Company unless the Managing Member(s) of the Company, other than the Member proposing to dispose of his/her/its interest, approved the transferee's admission into the Company as a Member, by unanimous written consent.

ARTICLE VIII: TERMINATION OF EXISTENCE

The Company shall be dissolved upon the death, bankruptcy, or dissolution of a Managing Member or upon the occurrence of any other event that terminates the continued Membership of a Member in the Company, unless the business of the Company is continued by the unanimous consent of the remaining Managing Members, or Member.

ARTICLE IX: MANAGEMENT

The Company shall be a manager-managed company in accordance with the Operating Agreement of the Company.

ARTICLE X

Except as otherwise provided by Florida law, no Member, Manager, Agent or Employee of the Company shall be personally liable for the debts, obligations or liabilities of the Company, whether arising in contract, tort or otherwise, or for the acts or omissions of any other Member, Manager, Agent, or Employee of the Company.
