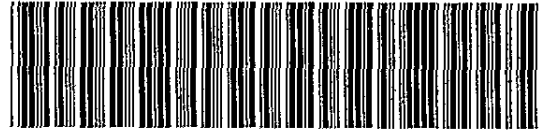



CCMS PROPERTIES GROUP, LLC is to be a member-managed company.


ARTICLE VI - Admission of Additional Members:
